#### REGINA, THURSDAY, OCTOBER 19, 1944

10 o'clock a.m.

This being the first day of the meeting of the First Session of the Tenth Legislature of the Province of Saskatchewan for the despatch of business, pursuant to a Proclamation of His Honour the Honourable Archibald Peter McNab, Lieutenant Governor of the Province, dated the eighth day of September, 1944, John Mason Parker, Clerk of the Legislative Assembly, Commissioner designated by His Honour the Lieutenant Governor for administering the Oath to the Members of the Legislative Assembly, attending according to his duty, John W. McLeod, Clerk of the Executive Council, delivered to the said John Mason Parker a roll containing a list of the names of such members as had been returned to serve in this Legislature, which are as follows, viz.:

The said Commissioner having previously administered the Oath to the members who appeared, and the members having subscribed the Roll containing the Oath, they took their seats in the Assembly at 3 o'clock p.m.

3 o'clock p.m.

His Honour the Administrator entered the Chamber and took his seat on the Throne.

The Honourable Mr. Valleau, Provincial Secretary, then said:

I am commanded by His Honour the Administrator to inform you that he will defer stating the reasons for which the Legislature has been

summoned until the Legislative Assembly have elected a Speaker. It is, therefore, His Honour's pleasure that the Legislative Assembly do now proceed to the election of a Speaker.

His Honour the Administrator then retired from the Chamber.

The Honourable Mr. Douglas (Weyburn), addressing himself to the Clerk, moved, seconded by the Honourable Mr. Fines, that Tom Johnston, Esquire, Member for the Electoral Division of Touchwood, do take the Chair of this Assembly as Speaker.

The question being put by the Clerk, it was

Resolved, nemine contradicente, that Tom Johnston, Esquire, do take the Chair of this Assembly as Speaker.

The Clerk having declared Tom Johnston, Esquire, duly elected, he was conducted by the Hon. Mr. Douglas (Weyburn) and the Hon. Mr. Fines to the Chair, where, standing on the upper step, he returned his humble acknowledgments to the Assembly for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

Thereupon he took the Chair and the Mace was laid on the Table.

3.15 o'clock p.m.

His Honour the Administrator re-entered the Chamber and took his seat upon the Throne.

Mr. Speaker then addressed His Honour to the following effect:

May it Please Your Honour,-

The Legislative Assembly have elected me as their Speaker, although I am but little able to fulfil the important duties thus assigned to me.

If in the performance of those duties I should at any time fall into error I pray that the fault may be imputed to me and not to the Assembly whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, hereby humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to your person at all seasonable times, and that their proceedings may receive from you the most favourable consideration.

The Honorable Mr. Valleau, Provincial Secretary, then said:

#### Mr. Speaker,—

I am commanded by His Honour the Administrator to declare to you that he freely confides in the duty and attachment of the Assembly to His Majesty's person and Government, and not doubting that their proceedings will be conducted with wisdom, temper and prudence, he grants, and upon all occasions will recognise and allow their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions and that its proceedings as well as your words and actions will constantly receive from him the most favourable construction.

His Honour the Administrator was then pleased to open the Session with the following speech:

Mr. Speaker and Members of the Legislative Assembly:

It is my privilege and pleasure to welcome you to the First Session of the Tenth Legislature of the Province of Saskatchewan.

Today, as I speak, Members of the Canadian Armed Forces, and among them soldiers, sailors and airmen from this Province, stand side by side with the soldiers of the allied nations in a struggle of liberation. It would be impossible to measure the full value of the contribution of these men and women, just as it would be impossible to express adequately our sense of gratitude and debt for what has been done.

The end of the conflict is in view. It would be foolish to be over-optimistic about the nearness of its termination. The people of this Province must be prepared to make efforts and sacrifices greater than ever before. My Government pledges full support and co-operation in the prosecution of this War. But, it is certain that within the life of this Legislature, the struggles of War will have ceased and the struggles of Peace will have begun. This Legislature sits under the shadow of a tremendous responsibility, for, in a large measure, it will aid in determining whether or not the sacrifices made in time of War were in vain.

The Tenth Legislature will be called upon to fulfil certain duties:

- 1. It must recognize the responsibility of the people of this Province towards members of the Armed Services as they return to civilian life, and it must utilize fully the machinery of government in extending a helping hand to those who have served their country;
- 2. It must create a governmental organization sufficient in scope to meet the needs of the postwar society;
- 3. It must implement legislation that will guarantee at least a minimum degree of economic security for the rural and urban working people of the province;
- 4. It must pass legislation that will endow a greater measure of social welfare upon those who, through no fault of their own, find it impossible to earn a satisfactory living;
- 5. It must implement legislation that will recognize the increasing importance of social enterprise in the economic life of the community;
- 6. It must enact legislation that will bring to fulfilment the pledges upon which this Government was elected. It must give direction to the people of this Province in establishing a more satisfactory social organization.

In recognition of these various duties, legislation will be introduced at this and coming Sessions that will aim at their fulfilment.

Recognizing the need for improved machinery of government to cope with the ever-increasing duties of modern governmental bodies, legislation will be introduced for the purpose of establishing and financing three new departments:

- 1. The Department of Social Welfare;
- 2. The Department of Labour;
- 3. The Department of Co-operatives and Co-operative Industrial Development.

It is the feeling of my Government that the day is past when it can be left to the forces of private enterprise exclusively to develop the resources of the community and to organize its business activity. The modern economy is a complex one that demands control and direction if disaster and chaos are to be averted. Well aware of the obstacles confronting any attempt at planning on a provincial scale, my Government remains of the opinion that much can be done to plan in such a manner that the economic activities of the people of this Province may be carried on more efficiently. An economic advisory committee is to be established whose purpose it will be to make enquiries and to advise the Government in establishing a planned type of economy for the Province.

To secure increased efficiency in the operation of government affairs, legislation will also be introduced for the purpose of establishing a Purchasing Agency. Under this Agency all Government purchases will be centralized. It is the conviction of my Government, that a considerable saving can be effected in this manner.

A number of boards and commissions hitherto operating upon a semi-autonomous basis are to be abolished or absorbed into the various departments in order to restore truly responsible government. This is being done in the belief that all branches of administration must be under the direct control of the elected representatives of the people.

To enjoy any degree of social well-being, every member of the community must have some security of tenure. It is the intention of my Government to introduce legislation to prohibit eviction under mortgage from the farm home of 160 acres. Crop failure legislation will be presented which will make it mandatory for the mortgagee to share crop failure risks with the farmer. Amendments to The Local Government Board Act will be introduced for the purpose of making orders of the Board binding on the Bond holders as well as on the Municipalities.

To enhance the security of other sections of the working population, my Government will bring in legislation designed to afford them greater protection against exploitation. A Collective Bargaining Bill will be introduced, designed to guarantee freedom of association among workers. It will offer them protection against unfair practices; it will guarantee their right to bargain collectively with their employers; and it will establish machinery whereby enforcement of agreements will be assured.

Acting upon the principle that the workers of this Province are entitled to some amenities of life, my Government will introduce a Vacations with Pay Bill. This Bill will be designed to provide workers with an opportunity to find some respite from the daily routine of work without loss of income.

These are but the first of a series of Bills to be introduced by the Government, directed toward giving Saskatchewan the most advanced labour legislation in the Dominion of Canada.

For the purpose of carrying out the third duty of my Government as previously mentioned—that of extending aid to the less fortunate members of the community, new legislation will be submitted and amendments to existing Acts will be introduced. Amendments to The Child Welfare Act, The Old Age Pensions Act, and The Education of Blind and Deaf Children Act, will be submitted for the purpose of enabling the Government to extend increased aid to persons coming under the provisions of these various Acts.

Grave concern has always been felt by the members of the present Government about the lack of adequate Health services in this Province. Dr. Henry E. Sigerist, Professor of the History of Medicine, Johns Hopkins University, was given a commission to survey the situation and make recommendations to the Government as to steps that may be taken to rectify it by the institution of some form of socialized health services. Dr. Sigerist's report has been tabled with the Executive Council. As the conditions of the wartime emergency become less stringent, legislation will be introduced to fulfil the spirit of this report. Certain immediate steps can and will be undertaken.

Legislation will be introduced providing free hospitalization and care for Mentally Incompetent persons. It is also the intention of the Government to introduce a Bill, the provisions of which will grant free medical care to Old Age and Blind Pensioners, and children and women in receipt of Mothers' Allowances.

It is the feeling of my Government that the time has come when governing bodies must realize their responsibilities in the sphere of economic life. When resources that are rightfully the property of the community are being exploited, then the members of the community must be adequately compensated and protected. When enterprises that should be properly recognized as public utilities are being operated by private interests to the detriment of the general welfare of the people of the Province, then it becomes the duty of the Government to act on behalf of the people to make sure that these enterprises are conducted in such a way as to yield the maximum benefit to the entire community. It is the policy of my Government to achieve these ends by every constitutional and financial power at its disposal.

A Bill will be introduced empowering the Government to enter into the Insurance business. There will be introduced a Mineral Taxation Act, to provide for the levying of a Provincial Tax on all mineral rights which have in the past been alienated from the Crown and are now privately owned. Acts will also be submitted designed to bring Fishing, Forestry and Trapping industries under the closer scrutiny of the Government. Attempts will be made to give direction to these industries with a view to securing in them a more efficient and economical operation.

In addition, attention is being given by my Government to the establishment of Social Investment upon a planned basis. It is with this end in view that the Department of Natural Resources will have its name changed to the Department of Natural Resources and Industrial Development. For the same purpose a Department of Co-operatives and Co-operative Industrial Development is to be established. It is the intention of my Government that this Department should give leadership and assistance in the development of these business undertakings which may be developed on a co-operative basis.

Special attention will be given to the re-establishment of members of the Armed Forces in civilian life. To this end the full energies of my Government will be devoted. It will be prepared at all times to co-operate in every way with other governmental agencies, particularly those of the Federal authorities. However, co-operation with these agencies is not enough. It is felt that the Provincial Government occupies a particularly strategic position which demands that it give additional leadership in re-settlement and re-establishment of these veterans.

All educational facilities in this Province will be made available for the purpose of providing training required by the men and women who leave the Armed Forces. Where it is found that facilities are inadequate, every attempt will be made to provide such schools, equipment and personnel as are necessary. As the situation demands, efforts will be made to secure the co-operation of the Federal Government in dealing with this problem.

Considerable attention has been given to the program of settling returned men on the land. It is the intention of my Government to make every effort to avoid the mistakes made in the Soldier Settlement Scheme that followed the last War. My Government proposes to take steps to supplement the program of Land Settlement as at present outlined by the Federal authorities. It is its intention to provide better grades of land for settlement. Much effort is being directed toward giving the soldier settlers an opportunity to establish co-operative farms as a new type of community land settlement.

While the whole policy of the Government is one of reconstruction, nevertheless there are special problems arising out of the post-war period. Therefore, my Government will ask that a Reconstruction Fund be created into which monies will be paid for the purpose of financing such schemes as housing, rural electrification and industrial development.

One of the major responsibilities of any democratic society is the education of the people. This demands facilities and curricula adequate to meet the need. My Government intends to proceed with the establishment of larger units of school administration. These units will serve to make available to the rural student many of the advantages now existent for the most part only in the urban centres.

It is also the belief of my Government that if adequate trained personnel is to be provided for the educational system, salaries must be brought into line with the duties and responsibilities of the teacher. For this reason, it is our intention to introduce a Bill asking for an increase in the minimum salary paid to members of the teaching profession. Then, too, there are glaring inequalities of financial resources existing as between various school districts. Legislation will be introduced designated to place greater resources at the disposal of the poorer school districts. No child's education should suffer because he or she is so unfortunate as to live in an economically poor area of the Province.

Mention should be made of certain actions of my Government since taking office on July 10th of this year. In response to the urgent need of the Kamsack area due to a disastrous cyclone, the Government acted to give assistance in a critical situation. A special grant was made; an Emergency Fund Committee was established; and my Ministers took an active part in rendering aid to the stricken community.

It was also necessary for my Government to take certain steps to ensure a supply of farm labour sufficient to harvest Saskatchewan's crops. Financial assistance was given by way of transportation grants to workers assisting in the harvest. Grants were also made to aid in the transfer of harvesting machinery to areas where it was needed.

An attempt has been made to reach a settlement of the 1938 seed grain advances. Since these were made during what was in reality a national emergency, certain proposals have been submitted to the Federal Government asking them to assume partial responsibility. To date, these proposals have not been accepted, nor has any alternative been suggested other than that full responsibility should be assumed by the people of this Province. My Government has intimated that it considers this proposal entirely unsatisfactory.

It is the feeling of the Government that some pronouncement should be made concerning the place of the Province of Saskatchewan within the framework of the Dominion economy. My Government emphasizes the importance of a "National Viewpoint" in dealing with the problems of rehabilitating the Canadian economy. The evils of provincialism which have been temporarily buried beneath the larger issues of a World War, are once more coming to the fore. Unless adequate recognition is given to these problems and a combined effort to assuage them is made by all governmental authorities in the Dominion, the whole structure of Canadian nationhood will be endangered.

It is the intention of the Government to press for a Dominion-Provincial Conference at the earliest possible date. At any such Conference, my Government would enter into negotiations with two major purposes in view:

- 1. That of finding some permanent basis for co-operation between the various governmental units in this Dominion;
- 2. That of securing a re-allocation of jurisdictional powers and a re-definition of responsibilities between the Dominion and Provincial

Governments with a view to dealing more adequately with the many problems facing the Canadian nation.

Legislation to amend various provincial statutes will be submitted for your consideration.

Members of the Legislature, I leave you to the consideration of the business of the Session, and trust that the blessing of Divine Providence may rest upon your labours.

His Honour the Administrator then retired from the Chamber.

Mr. Speaker informed the Assembly that the Clerk of the Legislative Assembly had received from the Clerk of the Executive Council lists of the names of such Members as had been returned to serve in the Legislature, as hereinbefore set forth,

And also notification of the following vacancy which had occurred in the Representation:

Ordered, That the Hon. Mr. Douglas (Weyburn) have leave to introduce a Bill respecting the Administration of Oaths of Office.

He accordingly presented the said Bill and the same was received and read the first time.

Mr. Speaker then informed the Assembly that, in order to prevent mistakes, he had obtained a copy of the Speech of His Honour the Administrator, which was laid on the Table.

On motion of the Hon. Mr. Douglas (Weyburn), seconded by the Hon. Mr. Corman:

Ordered, That the Speech of His Honour the Administrator be taken into consideration on Friday next.

On motion of the Hon. Mr. Douglas (Weyburn), seconded by the Hon. Mr. Brockelbank:

Ordered, That the Votes and Proceedings of this Assembly be printed after having been first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

On motion of the Hon. Mr. Douglas (Weyburn), seconded by the Hon. Mr. Valleau:

Ordered, That a Select Special Committee be appointed to prepare and report with all convenient speed, lists of Members to compose the Select Standing Committees of this Assembly, provided under Standing Order 45, said Committee to be composed of Messieurs Brockelbank, Valleau, Wellbelove, Patterson and Procter.

Such said Select Standing Committees to be severally empowered to examine and enquire into all such matters and things as may be referred to them by the Assembly, and to report from time to time their observations and opinions thereon, with power to send for persons, papers and records, and to examine witnesses under oath.

The Assembly then adjourned at 4 o'clock p.m.

#### REPORT OF THE LEGISLATIVE LIBRARIAN

Regina, 19th October, 1944.

To the Honourable.

The Speaker of the Legislative Assembly of Saskatchewan.

Sir:-

I have the honour to submit to you the Annual Report of the Legislative Library.

As in previous War years, limited privileges have been extended to members of the Armed Forces. A number of Saskatchewan teachers have also used the Parliamentary Records of the library in preparing their theses, and have expressed their appreciation of assistance given to them.

Research workers of the Saskatchewan Reconstruction Council made continuous use of facilities, including Post-War bibliographies, Government reports, pamphlet service, etc.

All resources of the library were also made available to the Health Survey Commission and appreciation was expressed by the Chairman, Dr. Sigerist, and Secretary, Dr. Sheps.

A reorganization of the Canadiana (notably Western) section has been started, and this, and the Archives, will be further developed in the future.

To the Law Library has been added many important books on Labour problems, etc. A notable addition was Butterworth's Legal Words and Phrases judicially defined (5 volumes).

For the Parliamentary section, the Debates of New Zealand have been ordered.

Books on the problems of Peace and Reconstruction predominate in the General collection.

To the periodicals have been added the Quarterly Journal of Economics (U.S.A.), the Journal of the Economic Society of Australia and New Zealand and the Daily Herald (Great Britain).

Major Malcolm James Dobie, Active Service Voters' Representative in the Legislative Assembly, for Canada outside Saskatchewan or in Newfoundland, having previously taken the Oath and subscribed the Roll containing the same, took his seat in the Assembly.

The Hon. Mr. Douglas (Weyburn), a member of the Executive Council, presented,—Return to an Order of the Assembly on motion of Mr. Patterson, dated October 25, 1944, showing:

- (1) What members of the Government took part in the Alberta Provincial Election.
- (2) For what periods they were absent from their offices in connection with this activity.

(Sessional Paper No. 7)

The Hon. Mr. Douglas (Rosetown), a member of the Executive Council, presented,—Return to an Order of the Assembly on motion of Mr. Danielson, dated November 6, 1944, showing:

- (1) Premises in the City of Regina rented by the Government.
- (2) Names of the parties from whom rented.
- (3) The rent paid.
- (4) Services provided by landlord.
- (5) Departments of Government accommodated.

(Sessional Paper No. 8)

Mr. Patterson asked the Government the following Question, which was answered by the Hon. Mr. Douglas (Rosetown):

(1) Has the Government purchased the property at 1100 Broad Street, Regina.

Answer: Yes.

(2) If so, from whom and at what price?

Answer: Mrs. Doris M. Smith; \$17,500.00.

Mr. Marion asked the Government the following Question, which was answered by the Hon. Mr. Douglas (Weyburn):

(1) Are appointments to the Department of Natural Resources made by the Minister or by the Public Service Commissioner?

Answer: Normally appointments are made direct by the Public Service Commissioner upon a requisition from the Department. In some instances, however, selections have been made by the Department and recommended to the Public Service Commissioner for confirmation. This has been done for the reason that because of present-day conditions and the scarcity of competent and suitable help, it has been found necessary to explore every avenue of possible supply and thereby assist the Public Service Commissioner in securing the desired help with the least possible delay, bearing in mind the fact that it has been found impracticable by the Public Service Commissioner to strictly adhere to the requirements of The Public Service Act in respect to appointments because of prevailing conditions.

Mr. Hooge asked the Government the following Question, which was answered by the Hon. Mr. Douglas (Weyburn):

- (1) What amount was paid to each member of the Sigerist Health Survey Commission for:
  - (a) Services;
  - (b) Expenses; and
  - (c) Other purposes?

Answer: Dr. H. E. Sigerist—sole member of the Commission. Amount paid for (a) services—\$1,000.00; (b) expenses—\$494.05; and (c) other purposes—nil.

Mr. Wooff asked the Government the following Question, which was answered by the Hon. Mr. Douglas (Weyburn):

(1) Was any change made in the position of H. A. Horsman by the Public Service Commissioner in 1942? If so, what change was made; on whose recommendation was the change made?

Answer: Yes, because of unsatisfactory service, from that of "Cook-Butcher" to "Assistant Cook" on the recommendation of the Superintendent of the Weyburn Mental Hospital, the Commissioner of Mental Services and the Deputy Minister, Department of Public Works.

- (2) Was H. A. Horsman suspended from duty while he was employed as an Attendant at the Weyburn Mental Hospital? If so, how long and for what reason?
  - Answer: Yes, from October 10th to 25th, 1932, for the pilfering of supplies belonging to the Institution.
- (3) Was a fine imposed on H. A. Horsman while he was employed as an Attendant at the Weyburn Mental Hospital? If so, when and for what reason?

Answer: Yes, in April of 1932 for neglect of duty.

- Mr. Marion asked the Government the following Question, which was answered by the Hon. Mr. Douglas (Weyburn):
  - (1) Is Dr. M. C. Sheps in the employ of the Government? If so, in what capacity and at what salary?
    - Answer: Dr. M. C. Sheps was employed as Secretary of the Saskatchewan Health Services Survey Commission from August 14th, 1944, to October 20th, 1944, at a salary of \$300.00 per month.
  - (2) Was this appointment made by the Public Service Commissioner?

    Answer: No.

His Honour the Administrator was then pleased to deliver the following Speech:

Mr. Speaker and Members of the Legislative Assembly:

It is my duty to relieve you of further attendance at the Legislative Assembly, and in doing so I wish to thank you and congratulate you upon the work you have done, and to express my confidence that the results of your labour will be of benefit to the people of the Province.

Many important matters have come before you for discussion and decision providing for security on the farm, guaranteeing to organized labour the right of collective bargaining and extending health services to certain groups in the Province, and I have observed with satisfaction the earnest attention you have given to these and all other matters of public interest.

I thank you for the provision you have made to meet the further requirements of the Public Service, and assure you that the sums of money voted will be used economically and in the public interest.

In taking leave of you I desire to thank you for the manner in which you have devoted your energy to the activities of the Session, and to wish you the full blessing of Providence as you return again to your respective homes.

The Hon. Mr. Valleau, Provincial Secretary, then said:

Mr. Speaker and Members of the Legislative Assembly:

It is the will and pleasure of His Honour the Administrator that this Legislative Assembly be prorogued until it pleases His Honour to summon the same for the dispatch of business, and the Legislative Assembly is accordingly prorogued.
