FOURTH SESSION—FOURTH LEGISLATURE

REGINA, THURSDAY, NOVEMBER 4, 1920

3 o'clock p.m.

This being the first day of the meeting of the Fourth Session of the Fourth Legislature of the Province of Saskatchewan, for the despatch of business, pursuant to a Proclamation of His Honour Sir Richard Stuart Lake, K.C.M.G., Lieutenant Governor of the Province, and dated the sixth day of October, 1920, and the Assembly having met,

His Honour the Lieutenant Governor entered the Chamber and, having taken his seat upon the Throne, was pleased to open the Session with the following Speech:

Mr. Speaker and Members of The Legislative Assembly:

I am pleased to welcome you to the fourth session of the Fourth Legislature of the Province. It is gratifying for me to be able to state at the outset that crop conditions are much more satisfactory this year than at the time of your last meeting, when it became my duty to recommend to your kind consideration the needs of many of our people in certain areas in the Province who were victims of the partial crop You responded by consenting to the failure from which we suffered. enactment of the necessary measures to meet the situation and to ratify the steps which had already been taken by my Government to cope with the urgency of the relief required, and for your action in this regard I now wish to express to you my most heartfelt thanks. This year the conditions are very much better, although we have not reaped the abundant crops with which Providence has blessed us during many seasons in the past. In view of the several successive crop failures in certain portions of the Province, such as the failure of last year, my Government has taken steps to study the question of combating the drought evil in the light of scientific and practical research. conference, presided over by the Minister of Agriculture, was held in July in Swift Current and was attended by many who had knowledge of the question both by investigation and by experience. this conference my Commission was issued to Dr. William J. Rutherford, Dean of the Faculty of Agriculture in the University of Saskatchewan, Professor John Bracken, Principal of the College of

Agriculture of Manitoba, Mr. George Spence, Member of your Assembly, Mr. Neil McTaggart of Gull Lake and to Mr. H. O. Powell of Weyburn, authorising them to inquire more fully into the matter with a view to producing a solution which will be beneficial to all our farmers. This most important subject will be submitted to you for discussion at this session.

Pursuant to the policy referred to by me in addressing you last year and contained in the enactment adopted by you at the last session creating the Bureau of Labour and Industries, steps have been taken by my Government to begin a research into such industrial potentialities of Saskatchewan as are contained in our natural resources. A report of the work already done in respect to this most important matter will be submitted to you during the present session.

In response to your Resolution in that behalf adopted last year, our people have been called upon by the Government of the Dominion of Canada to express themselves by means of a plebiscite upon the question of the importation of intoxicating liquor into Saskatchewan for beverage purposes. As you are aware the result of the plebiscite has been to place a ban upon such importations, and after the publication in the near future of the Proclamation of His Excellency the Governor General in Council bringing The Canada Temperance Act into effect no liquor will be imported legally into the Province excepting for medicinal, sacramental and scientific purposes. It is, however, a matter of great regret to my Ministers that so few of our people availed themselves of the opportunity provided for them at the polls to express themselves upon a question of such great social and administrative I may also call your attention to the fact that I have issued my Proclamation bringing into effect the provisions of the new Saskatchewan Temperance Act on December 15th next.

Pursuant to an Act of this Legislature passed during the second session of the year 1917 to provide for the consolidation and revision of the Statutes of Saskatchewan, my Commission issued on December 15th of the same year to the Honourable Mr. Justice Henry William Newlands, the Honourable William Ferdinand Alphonse Turgeon, the Attorney General of Saskatchewan, Mr. Thomas Arthur Colclough, Barrister, at that time Deputy Attorney General, and to Mr. Robert Walker Shannon, Legislative Counsel, empowering them to make the required consolidation and revision. The Commissioners have completed this important task and their report will be laid before you at an early date in this session.

Reports will also be made to you by my Ministers concerning the progress made regarding the question of a water supply from the South Saskatchewan River to certain areas in the Province; the inquiry into the subject of mental hygiene; the construction of the new Mental Hospital at Weyburn; co-operation with the Government of the Dominion regarding highway construction; and several other matters which have been under way since you last met.

Among the important matters of legislation with which you will be asked to deal you will find a proposal for increased Grants for educational purposes and particularly to the elementary and secondary schools of the Province. The Public Accounts of the last fiscal year will be submitted to you as well as Estimates of revenue and expenditure for the year beginning May 1, 1921.

I leave you now to your labours and invoke the Divine blessing upon your deliberations.

His Honour the Lieutenant Governor then retired from the Chamber.

Mr. Speaker informed the Assembly that the Clerk of the Assembly had received from the Clerk of the Executive Council notifications of the following vacancy in the Representation, viz.:—

The Hon. Charles McGill Hamilton, Member for the Electoral Division of Weyburn, having previously taken the Oath according to law, and subscribed the Roll containing the same, took his seat in the Assembly.

Ordered, That the Hon. Mr. Martin have leave to introduce a Bill respecting the Administration of Oaths of Office.

He accordingly presented the Bill to the Assembly, and the same was received and read the first time.

Mr. Speaker then informed the Assembly that, in order to prevent mistakes, he had obtained a copy of the Speech of His Honour the Lieutenant Governor, which was laid on the Table.

On motion of the Hon. Mr. Martin, seconded by the Hon. Mr. Turgeon,

Ordered, That the Speech of His Honour the Lieutenant Governor be taken into consideration on Monday next.

On motion of the Hon. Mr. Martin, seconded by the Hon. Mr. Langley,

Ordered, That the Votes and Proceedings of this Assembly be printed after having been first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

On motion of the Hon. Mr. Martin, seconded by the Hon. Mr. Turgeon,

Ordered, That a Select Special Committee be appointed to prepare and report with all convenient speed, lists of Members to compose the Select Standing Committees of this Assembly, provided under Rule 10, said Committee to be composed of Messieurs Martin (Regina City), McNab, Garry, Maclean and Badger.

Such said Select Standing Committees to be severally empowered to examine and inquire into all such matters and things as may be referred to them by the Assembly, and to report from time to time their observations and opinions thereon, with power to send for persons, papers and records, and to examine witnesses under oath.

The Assembly then adjourned at 3.20 o'clock p.m.

MAY IT PLEASE YOUR HONOUR:-

This Legislative Assembly at its present Session passed several Bills, which, in the name of the Assembly, I present to Your Honour and to which Bills I respectfully request Your Honour's assent.

Whereas early in July, 1919, the Grain Exchanges were allowed to open for the purpose of marketing the wheat crop of 1919, and

Whereas after being open for less than a month they were again closed by Government order, and by an Order of the Governor General-in-Council dated July 31st, 1919, the Wheat Board was created to market the wheat crop of 1919, and

Whereas that body marketed the wheat crop of 1919 to the great benefit and satisfaction of the farmers, and

Whereas as the result of opening the Exchanges to market the wheat crop of 1920 the price of wheat has declined seventy-five cents a bushel although the world's supply of wheat does not appear to be any larger in 1920 than it was in 1919;

Therefore, be it Resolved, That this Assembly, representing the largest wheat growing province in the Dominion, urge the Government of Canada to reappoint at once the Wheat Board, with the chairman and assistant chairman of last year, to take charge of and market the balance of this year's wheat crop.

REPORT OF THE LEGISLATIVE LIBRARIAN.

Regina, November 9, 1920.

To the Honourable,

The Speaker of the Legislative Assembly of Saskatchewan.

I have the honour to lay before you the report of the Legislative Library. All sections of the Library have been more or less strengthened during the year; but special mention may be made of the law department. Much progress has been made recently in building up this most important and indispensable section.

In May of 1919 an order was given to the Carswell Company, To onto, for a complete set of Upper Canada Reports, beginning with Taylor's King's Bench Reports, 4 Geo. IV., 1823, and extending down to the establishment of the Ontario Reports. In September of the present year the library purchased from the Canada Law Book Company the Nova Scotia Supreme Court Reports, 54 volumes, the New Brunswick Supreme Court and Equity Reports stretching back to 1825, 51 volumes, and the Prince Edward Island Reports, 2 volumes. The Carswell Company with its order included, as a free gift, Hodgins' Election Cases, one volume, and the Ontario Election Cases, 2 volumes. The Canada Law Book Company also gave us, free of charge, the Nova Scotia Election Cases, 1874.

The additions thus made have put the library in possession of a substantially complete series of Canadian Reports with the exception of those of Quebec, the call for which, as being largely taken up with cases under the civil law, was considered less urgent.

Important new publications or new editions of standard text books have also been procured from time to time under the authority of the Legislative Counsel.

The policy which dictated the above purchases was founded upon the opinion that in the employment of limited resources allowing only of a gradual extension of the collection, the most suitable procedure for a provincial library is to complete its Canadian Reports, the English Law Reports dating from 1866 being already on the shelves, before acquiring the old English Reports or those of foreign jurisdictions. This has now been done, with the exception above noted, and an excellent working law library has been provided for the Legislature and those officials whose duties require the assistance of such a library.

I should like, in this connection, to acknowledge the indebtedness of the Library to the learned Legislative Counsel, R. W. Shannon, Esq., K.C., whose advice and assistance in building up the legal section has always been most readily and courteously given.

All available shelving being occupied it has been found necessary to extend the stacks to the open floor. This has necessitated an entire re-arrangement of the library, every book having to be moved in order to make the best of the space. This arduous work has been well performed by Mr. W. H. Munro, the assistant librarian, and Miss Pithie, the cataloguer. No effort has been spared to make the Library of service to the various government departments, and to those people who come from outside to work in it, and make use of it for the purposes of reference.

I have again to cordially acknowledge the efficient and unwearying services of the Legislative and Travelling Libraries' staffs.

REPORT ON THE TRAVELLING LIBRARIES.

To the Honourable,

Regina, November 9, 1920.

The Speaker of the Legislative Assembly of Saskatchewan.

I have the honour to report as follows in connection with the Travelling Libraries.

The demand for these libraries is steadily increasing. at present 365 in circulation, and 35 unfilled applications on hand, which will be filled within a month, so that before Christmas there will be at least 400 libraries in circulation. In November last year there were 225 in circulation. Last fall our appropriation was practically exhausted by Christmas, and as most of our applications come in during the winter, we had more than enough on hand to use up this year's The importance of this branch of appropriation before we got it. service, and the urgent need of additional money if it were to be continued, was laid before the Government, with the result that a "supplemental" of \$10,000 was voted in June last to enable us to carry on the work this fall and winter. This was a generous supplemental, but under present conditions it costs practically \$100 to equip a new library, and the cost of keeping up the old libraries is no small item.

It is impossible to estimate the development this winter, but the present indications are that we will receive all the applications we can fill, and probably more. The fact that there is this government service is being gradually more widely known through articles in the Grain Growers' Guide and other publications, the Grain Growers' Association, Inspectors of the Department of Education, Supervisors of the Soldier Settlement Board, and also through the exhibit at the Regina Exhibition in July last. This exhibit was a revelation to scores of visitors, many of whom had never heard of the Travelling Libraries, and who expressed their approval in no uncertain terms.

During the last year we had to secure additional help. One new member has been added to the staff, and for part of the time we have the services of a bookbinder from the King's Printer's Department to mend and rebind books which are too badly worn to be mended by us. So far he has rebound almost 1,000 books, and the most of these are stronger now than when they were new.

Letters of appreciation are daily received and it will be gratifying for you to know that the people in the rural districts not only appreciate the opportunity of getting reading material, but also appreciate the kindness of the Government in making this opportunity possible.

This department is bound to develop and develop very rapidly, and in the interests of the people of this Province, I hope that it will be possible to have financial provision made each year to take care of this development.

- (3) What percentage of this cost was charged to the municipalities?

 Answer: Fifty per cent.
- (4) What amount has been collected from municipalities to date?

 Answer: \$26,754.80.
- (5) What acreage of crops was destroyed by grasshoppers in 1920? Answer: It is estimated at approximately 45,000 acres.
- (6) What area of infested crop was saved?
 - Answer: Computed from replies received from Municipal Secretaries in answer to a questionaire sent out by the Field Crops Commissioner, and from reports of Field Representatives of the Department, it is estimated that approximately 1,400,000 acres of crop was saved.
- (7) What is the estimated value of the infested crop saved? Answer: Approximately \$25,000,000.

Mr. Dodds asked the Government the following Question, which was answered by the Hon. Mr. Hamilton:—

- (1) What number of mortgagees utilised the Government guarantee under The Seed Grain Advances Act, 1920?

 Answer: 55.
- (2) What was the total number of guarantees given in connection therewith?

 Answer: 2,727.
- (3) What was the total amount of advances guaranteed? Answer: \$694,148.28.

- (2) What is the result of the trial installation of the Automatic Telephone equipment made at Qu'Appelle?

 Answer: Answered in number one.

Whereas to meet war conditions and protect the general public the Government of Canada fixed a price for the Canadian wheat crops of 1917 and 1918, and

Whereas early in July, 1919, the Grain Exchanges were allowed to open for the purpose of marketing the wheat crop of 1919, and

Whereas after being open for less than a month they were again closed by Government order, and by an Order of the Governor General-in-Council dated July 31, 1919, the Wheat Board was created to market the wheat crop of 1919, and

Whereas that body marketed the wheat crop of 1919 to the great benefit and satisfaction of the farmers, and

Whereas as the result of opening the Exchanges to market the wheat crop of 1920 the price of wheat has declined seventy-five cents a bushel although the world's supply of wheat does not appear to be any larger in 1920 than it was in 1919:

Therefore, be it Resolved, That this Assembly, representing the largest wheat growing province in the Dominion, urge the Government of Canada, to reappoint at once the Wheat Board, with the chairman and assistant chairman of last year, to take charge of and market the balance of this year's wheat crop.

The debate continuing, and the question being put, it was agreed to unanimously.

On motion of the Hon. Mr. Langley, seconded by Mr. Robinson,

Resolved, That an humble Address be presented to His Honour the Lieutenant Governor, praying that a copy of a Resolution respecting the reappointment of the Wheat Board of Canada be forwarded to the Secretary of State of Canada for transmission to His Excellency the Governor General in Council.

By leave of the Assembly, the Order "Motions" was reverted to.

Moved by Mr. Dunbar, seconded by Mr. Fraser,

Whereas the export traffic in intoxicating liquors from points in the Southern part of Saskatchewan to points in the United States of America has been for the past several months and is now the occasion for great disorders and in some cases actual terrorism, such as the carrying of firearms, assaults, thefts and other serious offences of great detriment to the peace and order of the localities affected; and

Whereas it is urgently required in the public interest that all proper measures be taken at the earliest possible moment to put an end to such export traffic, and particularly that competent legislation be provided to render such traffic illegal; and

Whereas it was held by the Court of Appeal for Saskatchewan in its judgment in the case of Hudson's Bay Co. v. Heffernan upon the question of the validity of an Act to abolish export liquor houses passed by the Legislature in 1917 that it is not within the competence of the Legislature of this Province to enact laws to put a stop to the said export traffic, as may be instanced by the following paragraph in the said judgment:—

"This Act does not pretend to deal with local transactions in liquor, but with transactions between Provinces and between Saskatchewan and foreign countries, thus interfering with trade and commerce, a matter which is not within the jurisdiction of a Provincial Legislature;" and

Whereas under the constitution of Canada it therefore follows that the matter in question is one calling for Federal action, and it is undoubtedly within the power of the Federal authorities to declare the said traffic illegal and to put an end to the export liquor business:

Therefore, be it Resolved, That, in the opinion of this Assembly, steps should be taken at once to urge upon the Government of the Dominion of Canada the necessity of having effective measures taken at the earliest possible moment to put an end to the situation which now exists in the localities in question.

A debate arising, and the question being put; it was agreed to unanimously.

Therefore, be it Resolved, That, in the opinion of this Assembly, the Dominion authorities should be petitioned to appropriate at the earliest possible date sufficient sums of money to complete the branch lines of the Canadian National Railways which are already projected into various sections of the Province, and that they should be urged to continue construction work on such branch lines and complete such branch lines at the earliest possible date.

In the case of the Bresaylor crossing: Owing to the opening of the Turtleford line of the Canadian National Railway the traffic hitherto using the ferry to market at Bresaylor, found nearer market points on the Turtleford line and therefore the necessity for this ferry no longer exists.

(4) How many new ferries have been installed during the season of 1920?

Answer: Two (2).

One over the Beaver river north-west of Meadow Lake in township 61, range 19 west of the 3rd meridian, and one on the fourth meridian line north of Lloydminster on section 25, township 53, range 28 west of the 3rd meridian.

(5) If any, what were the reasons for installing such new ferries?

Answer: In the case of the Beaver River Ferry: This new ferry was required to accommodate the increasing number of settlers going into districts between the Beaver and Waterhen rivers for stock raising.

In the case of the ferry on the 4th meridian line: The ferry belonging to the Alberta Government west of the meridian line, proving unsuccessful, and the ferry in Saskatchewan at the old Fort Pitt crossing becoming extremely difficult to maintain continuously and satisfactorily and the requirements of the people living north of the river needing a direct crossing immediately north of Lloydminster, made it apparent that this crossing could converge the traffic and was absolutely necessary to enable settlers north of the river to get to their nearest market town, which is Lloydminster. The Government of Alberta is bearing half the expense of the installation and operation of this ferry. The Government of Saskatchewan is operating the ferry.

Whereas there are a number of branch lines of the Canadian National Railways in the Province of Saskatchewan, some of which have been projected for many years; and

Whereas on some of the branch lines construction work has been carried on in recent years very slowly and thus prevented the development of the Province and militated against the prosperity of the people; and

Whereas many people in the Province were induced in years past to locate in certain sections of the country by reason of the fact that the branch lines were projected in order to furnish much needed railway facilities; and

Whereas many people are still without such facilities; and

Whereas the development of the Province and the success of the people depend in a very large measure upon the extent to which transportation facilities are provided; and

Whereas many of the people in the Province are at the present time seriously handicapped by reason of the fact that they have no railway facilities within reasonable distance and are therefore compelled to spend time and money in obtaining their supplies and in

drawing their grain to market:

Therefore, be it Resolved, That, in the opinion of this Assembly, the Dominion authorities should be petitioned to appropriate at the earliest possible date sufficient sums of money to complete the branch lines of the Canadian National Railways which are already projected into various sections of the Province, and that they should be urged to continue construction work on such branch lines and complete such branch lines at the earliest possible date.

The debate continuing, and the question being put, it was agreed

to unanimously.

On motion of Mr. Gemmell, seconded by Mr. McDonald,

Resolved, That an humble Address be presented to His Honour the Lieutenant Governor, praying that a copy of a Resolution respecting the construction and completion of the branch lines of the Canadian National Railways in Saskatchewan be forwarded to the Secretary of State of Canada for transmission to His Excellency the Governor General in Council.

The Assembly then adjourned at 5.30 o'clock p.m.

Answer: Yes; one in township thirty-one (31) range sixteen (16) West of the third (3) meridian, and one in townships thirty-seven (37) and thirty-eight (38) range twenty (20) West of the second (2) meridian.

These prices include the moving of the crews and outfits to and from the jobs, hauling construction materials and doing a certain amount of grading to the earth approaches of the bridges. The costs given are based upon the average costs of the bridges constructed in the years mentioned.

The factors of this increase have been:

The rise in the price of piling from 6c and 8c per lineal foot in 1914 to 15c per lineal foot in 1920; and the rise in the price of timber—

Coast material, from \$13.00 per thousand in 1914 to \$27.00 and \$34.00 per thousand in 1920;

Mountain material, from \$15.00 per thousand in 1914 to \$38.00 and \$41.00 per thousand in 1920;

and the increase of freight rates on timber—from Coast points, from 40c in 1914 to 66c in 1920; from Mountain points, from 26c in 1914 to 44½c in 1920;

and the rise in prices of iron and steel bars from \$2.33 per hundred pounds in 1914 to \$4.50 per hundred pounds in 1920;

and the increase in freight rates on this metal, from Winnipeg to Regina, from 55c in 1914 to 93c in 1920.

Whereas agriculture is the basic industry of Canada and especially of Saskatchewan, the prices received for the products of which are regulated by world prices whether sold within or without Canada, the result being that the agricultural industry carries all the burdens of the tariff without receiving any of its benefits; and

Whereas the high cost of living, which is largely the result of the said tariff, bears upon our citizens, both rural and urban, to such an extent as to gravely jeopardise the financial ability of our people to bear the ever increasing load; and

Whereas Canada is now confronted with a huge national war debt and greatly increased financial obligations which can be most readily and effectively reduced by the development of our natural resources, chief of which is agricultural lands; and

Whereas our returned soldiers have heroically and at great sacrifice in common with their comrades of all the allied armies, achieved for us a signal victory, and have now returned to us and in many instances are resuming or beginning the business of agriculture and deserve every consideration, encouragement and fair play; and

Whereas the protective tariff has resulted in the creation of trusts, mergers and combines under which the common people generally have been outrageously exploited through the elimination of competition, the ruination of many small industries and the advancement of prices on practically all manufactured goods to the full extent permitted by the tariff;

Therefore, be it Resolved, That, in the opinion of this Assembly, it is the duty of the Government of Canada at the coming session of Parliament to introduce legislation which shall have for its effect the following:

- (1) An immediate and substantial all-round reduction of the Customs Tariffs.
- (2) The reduction of the Custom Duty on goods imported from Great Britain to one-half the rates charged under the general

tariff, and that further gradual uniform reductions be made to the remaining tariff on British imports that will ensure complete free trade between Great Britain and Canada.

- (3) The placing upon the free list of all foodstuffs not included in the Reciprocity Agreement.
- (4) The placing on the free list of all agricultural implements, farm machinery, farm tractors, mining, flour and saw-mill machinery and repair parts thereof, vehicles, fertilizers, gasoline, illuminating, lubricating and fuel oils, coal, lumber, cement, fishing nets, net twines and fishermen's equipment, as well as the raw material and machinery used in their manufacture.
- (5) The reduction of the Customs Duty on wearing apparel and footwear and other articles of general consumption (exclusive of such articles as may be regarded as luxuries) and on such raw material as-enters into the manufacture of the same.
- (6) The immediate extension to Great Britain of all tariff concessions granted to other countries.
- (7) The obligation upon all corporations engaged in the manufacture of products protected by the Customs Tariff to publish annually comprehensive and accurate statements of their turnovers and earnings.
- (8) The public hearing before a special Committee of Parliament of every claim for tariff protection by any industry.
- (9) The acceptance by the Parliament of Canada of the Reciprocity Agreement of 1911, which still remains on the United States Statute Books.

Answer: The Commissioner, Saskatchewan Provincial Police, Regina, has received instructions from the Government to make exhaustive inquiries and to submit a report to the Government. The Commissioner has been making inquiries for some time, and, in the event of a favourable report being submitted, it is the intention of the Government to instal wireless stations at certain points throughout the Province.

Mr. Jones asked the Government the following Question, which was answered by the Hon. Mr. Turgeon:—

(1) How many Provincial Police are there in the Province?
Answer: 138, consisting of the following officers and men:—
(a) Commissioner
(b) Assistant Commissioner 1

Total of officers and men

(2) Who is responsible for the enforcement of The Saskatchewan Temperance Act in the cities and towns in Saskatchewan?

Answer: In cities and towns in the Province of Saskatchewan the municipal police thereof are charged with, and responsible for, the enforcement of The Saskatchewan Temperance Act, but should a request be made by a responsible municipal authority of a city or town in the Province of Saskatchewan for the assistance or co-operation of the Saskatchewan Provincial Police, such request is complied with. In addition the Chief Inspector and Inspectors under The Saskatchewan Temperance Act 1920, are invested with enforcing powers in so far as drug stores are concerned.

Mr. Turner asked the Government the following Question, which was answered by the Hon. Mr. Turgeon:—

(1) Has the Government any knowledge of the arrangements made by the Saskatchewan Liquor Commission to secure an adequate supply of medicinal intoxicants?

Answer: Pursuant to the recommendation of the Liquor Commission the Lieutenant Governor in Council has, by Order in Council, authorised Boivin, Wilson & Company, Limited, and the National Drug and Chemical Company of Canada, Limited, both of which companies carry on the business of wholesalers in the City of Regina and in the City of Saskatoon in the Province of Saskatchewan, to sell liquor by wholesale to physicians or retail druggists and to any of the classes of persons mentioned in section 101 of The Saskatchewan Temperance Act 1920.

(2) If so, what are the arrangements?

Answer: Upon the payment to the Attorney General of a license fee of \$1,000.00 in respect of each place of business kept and maintained in the City of Regina and in the City of Saskatoon for the period on, from and after the fifteenth day of December, 1920, to the thirty-first day of December, 1921, the wholesalers may sell liquor by wholesale to physicians or retail druggists and to any of the classes of persons mentioned in section 101 of The Saskatchewan Temperance Act 1920.

(3) Is it within the power of the Saskatchewan Liquor Commission to give to any one wholesale firm a monopoly on the selling of medicinal intoxicants in Saskatchewan?

Answer: Under the provisions of section 38 (1) of The Saskatchewan Temperance Act 1920 the Lieutenant Governor in Council determines the terms and conditions upon which liquor shall be supplied by wholesalers to druggists and others who may legally dispense liquor. The Lieutenant Governor in Council in such cases has acted upon the recommendation of the Liquor Commission. No limitation exists upon the powers of the Lieutenant Governor in Council in this regard.

(4) Has the Saskatchewan Liquor Commission appraised the Government of the price at which it is expected that intoxicating medicine will be sold by the retailer after The Saskatchewan Temperance Act 1920, comes into effect?

- Answer: The Saskatchewan Liquor Commission have no power under The Saskatchewan Temperance Act 1920, or any regulations made thereunder to fix or control the retail price of intoxicating liquor.
- (5) If so, what is the price?

 Answer: Answered by No. 4.

That any person who is not the execution debtor but who bears a name similar to that of the execution debtor may send a letter or notice in writing to the Registrar of Land Titles requiring him to give notice to the solicitor or solicitors for the execution creditor stating that unless a Judge's Order continuing the execution is filed within twenty days from the date of the giving of the notice the execution will be of no effect as regards the lands of the party so notifying the Registrar;

That in the event of failing to obtain such Judge's Order within the said twenty days then the Registrar shall be required to cancel such execution in so far as it affects the lands of the party notifying the Registrar;

That said notice be sent by the Registrar to the solicitor or solicitors of the execution creditor without cost

- (a) to the party giving the notice to the Registrar;
- (b) to the solicitor or solicitors of the execution creditor as in the case of notice in respect of caveats.

Mr. Speaker then said:--

MAY IT PLEASE YOUR HONOUR,

This Legislative Assembly has voted the Supplies required to enable the Government to defray the expenses of the Public Service. In the name of the Assembly I present to Your Honour the following Bill:—

An Act for granting to His Majesty certain Sums of Money for the Public Service of the Fiscal Years ending respectively, the Thirtieth Day of April, 1921, and the Thirtieth Day of April, 1922.

The Royal Assent to this Bill was announced by the Clerk:--

"In His Majesty's name, His Honour the Lieutenant Governor doth thank the Legislative Assembly, accepts their benevolence and assents to this Bill."

His Honour then delivered the following Speech:

Mr. Speaker and Members of the Legislative Assembly:

Having concluded the work of the Fourth Session of the Fourth Legislature, it is my duty to relieve you from further attendance and to congratulate you upon the work you have accomplished. I desire to express confidence that the result of your labours will be beneficial to the province.

A number of important questions have come before you for discussion and decision and I have observed with much satisfaction that your careful attention has been given to all of these to the end that the best public interest may be served.

I note with pleasure the splendid financial condition that has enabled you to reduce taxation by the abolition of the Supplementary Revenue Tax and at the same time to make further large increases in the grants for educational purposes. I am sure that this action will result in material benefit to our people.

My Ministers are confident that the approval of the citizens of Saskatchewan will be given to your action in formally adopting certain addresses for presentation to His Excellency the Governor General of Canada and his advisors, formulating important demands regarding several matters of provincial interest but under Federal jurisdiction, and I assure you that your requests that these be forwarded to the proper authorities have been complied with.

The liberal provision you have made to meet all the needs of the public service is a matter for which I thank you and I assure you that the funds thus voted will be used economically and in accordance with the priciples of sound administration.

In taking leave of you I express the sincere hope that Divine Providence will continue to bless our province, and I give to you and all our people my heartfelt greetings for the Christmas season and best wishes for the New Year.

The Hon. Mr. Knowles, Provincial Secretary, then said:
Mr. Speaker and Members of the Legislative Assembly:

It is the will and pleasure of His Honor the Lieutenant Governor that this Assembly be prorogued until it pleases His Honour to summon the same for the dispatch of business, and the Legislative Assembly is accordingly prorogued.
