THIRD SESSION—THIRD LEGISLATURE

REGINA, TUESDAY, SEPTEMBER 15, 1914.

3 o'clock p.m.

This being the first day of the Third Session of the Third Legislative Assembly of the Province of Saskatchewan, for the despatch of business, pursuant to a Proclamation of His Honour George William Brown, Lieutenant Governor of the Province, dated the twenty-fourth day of August, 1914, and the House having met, His Honour entered the House and having taken his seat upon the Throne was pleased to open the Session with the following speech:

Mr. Speaker and Gentlemen of the Legislative Assembly:

You have been summoned to meet at an unusual time on account of circumstances which have resulted from the war in which we as a part of the British Empire are involved.

The call to arms has been responded to nowhere more promptly than in our province. In addition to the share borne by our people in the measures taken by Canada for the defence and integrity of the Empire, my Government have offered, through the Governor General in Council, a gift of horses as a direct contribution from Saskatchewan. This offer has been accepted. A measure sanctioning the gift will be submitted to you.

Not the least important part of the grave responsibility resting upon us at this time is to assist in safeguarding the welfare of the families of the men who are selected for active service, including not only Canadian volunteers, but all British, Belgian, French, Russian, Servian and Japanese reservists who have left dependents in Saskatchewan. A Dominion Patriotic Fund has been incorporated with this end in view. Your approval will be asked for a substantial money grant to the fund.

Economic and business conditions within the province naturally have not escaped a degree of untoward influence from the gigantic conflict which is being waged. Proposals which, therefore, are made advisable and which will enable our people to cope with unprecedented conditions, are to be presented for your consideration.

The issues at stake at this moment are so tremendous and the developments of the immediate future so impossible to estimate that no one may predict with any certainty whether a subsequent session of the Legislative Assembly will not be imperative. In the interest of economy, however, in the event of no necessity arising for calling you together again within the year, Estimates of the Revenues and Expenditures for the next fiscal period will be placed before you.

The crisis confronting the people of the Empire has brought indisputably into prominence the fact of the unity of sentiment upon supreme issues actuating the inhabitants of every section of the British Dominions throughout the globe without a single exception. The steady determination and calm confidence with which one and all have undertaken the responsibility suddenly thrust upon us inspires and justifies the hope of a favourable and honourable outcome.

I commend the people of this province and you in the deliberations of the session to Divine protection and guidance.

His Honour was then pleased to retire.

In relieving you from your duties I desire to commend to the protection of Divine Providence the people of our Province and at the same time join with you in the hope that the great conflict in which the Empire is now involved will be favourably and honourably concluded.

The Hon. Mr. Turgeon then said:

MR. SPEAKER AND GENTLEMEN OF THE LEGISLATIVE ASSEMBLY:

It is His Honour the Lieutenant Governor's will and pleasure that this Legislative Assembly be prorogued until it pleases His Honour to summon the same for the despatch of business, and the Legislative Assembly is accordingly prorogued.
